

NCER Policy – Cross-Border Analysis - 2021

NCER is a Community Interest Company co-owned by all the top-tier local authorities in England, a total of 153-member local authorities including the Services Authority. Our only purpose is to meet local authorities' needs for high-quality national, local, school and pupil-level analysis of education data.

NCER now offers the opportunity for an individual member local authority to request a predefined set of data extracts and/or analysis that has aggregate data for a wider grouping of schools involving 2 or more-member local authorities.

Cross Border Analysis - School groups

NCER will only permit requests for groups of schools - such as MAT and/or Diocesan Authority analyses - after **every** local authority with a school included within the request has formally agreed in writing to the NCER Managing Director and every authority has set up the necessary arrangements (trading, direct access, data governance etc) for doing so. If a local authority does not provide permission for the inclusion of schools within their local authority the affected schools' analysis will not be provided. Such local authority agreements would have to be renewed on an annual basis.

NCER will require the member authority to confirm that they have advised their relevant schools that their school data is being included within this agreement.

Cross Border Analysis – Local Authority level

The NCER Management Board would expect an individual local authority to act on behalf of a group of member local authorities to coordinate relevant permissions ahead of a request for a data extract from NCER. Requests will only be acted upon when every local authority affected has formally agreed in writing to the NCER Managing Director. This data extract would be provided at a local authority level and would not include performance of individual schools in the authority's party to the agreement.

Making a request

Local authorities requesting additional data extracts are required to complete the 'Cross-Border Analysis – School Data to Include' form included as *Annex A* and the 'Cross-Border Analysis – Local Authority Permission' *Annex B* form.

These forms are required to act as a clear audit trail for NCER and are in addition to any other documentation required by individual schools, local authority or the NCER Managing Director.

There will be a standard set of Key Stage and Indicator analysis that will be provided following the receipt of all relevant permissions by the NCER Managing Director (*Annex C*). If other or more detailed analysis is required a formal request will need to be raised with the NCER Development Director. Such requests will be considered against other development priorities and will only be progressed if they are assessed as high priority developments offering value for money to the NCER Membership.

Data included within Cross-Border Analysis will be subject to suppression of small numbers.

- Identify a lead Local Authority that will coordinate the collation of relevant documentation.
- For school level data, ensure all schools have been advised
- Complete all permissions forms and submit them to NCER Managing Director for consideration.
- Following approval, lead Local Authority will receive standard data extract from Angel Solutions.
- Permissions will need to be resubmitted to the NCER Managing Director on an annual basis.
